What is a Clinical Commissioning Group (CCG)?





What is a Clinical Commissioning Group?

Clinical Commissioning Groups (CCG) are the new NHS organisations created through the Health Reforms, who will replace Primary Care Trusts in April 2013.

CCGs will be responsible for "commissioning" - planning, designing and paying for NHS services to meet the needs of the local population.

Each CCG has gone through a strict authorisation process to ensure that they can commission services effectively and safely, this was overseen by the NHS Commissioning Board (NCB).

The new national NHS Commissioning Board will oversee the performance of CCGs, as well as commissioning GP services, pharmacies, opticians and dentists, and other specialised services.

In order to keep decision making as close to patients as possible Local Doctors and

Clinicians have been made the leaders of the new CCGs.



Who are St Helens Clinical Commissioning Group?

St Helens Clinical Commissioning Group are taking over responsibility for local healthcare from the Primary Care Trust, NHS Halton and St Helens.

Dr Stephen Cox, a local Doctor is our Clinical Accountable Officer and we have a lay Chair, Bill Guest.

Every Doctors surgery in St Helens is signed up as a member of the CCG and therefore has a say in the services we buy.

Our Governing body is made up of a group of Doctors from St Helens Practices, along with representatives from the Local Authority, a Secondary Care Doctor from a nearby Hospital and a number of Lay Members.

We work closely with a number of NHS providers in the area including:

- Bridgewater Community NHS Healthcare Trust (services like District Nursing)
- St Helens and Knowsley Teaching Hospitals NHS Trust (Whiston & St Helens Hospitals)
- 5 Boroughs Partnership NHS
 Foundation Trust (mental health services)
